**Policy:** Rent is billed quarterly and Austin's does not reimburse. If you decide to purchase an instrument, 100% of your accumulated rental may be applied up to 30% (not to exceed \$1000.00) of the retail value of ANY instrument offered at Austin's, up to 20% of the value of any case, and up to 10% of the value of any bow. Rental NEVER expires.

**Payment:** Renters will be billed every 3-month period for the duration of the rental agreement. A late charge of \$5.00 per month will be assessed to any rental payment made more than 5 days after the due date. Accounts in arrears past 60 days will be referred to a collection agency or attorney. In such cases, if renter fails to make payment in full, Austin's will have the right of collect from the renter all back rent and late fees owed, plus the replacement value of the instrument outfit(s) if not returned to Austin's Violin Shop, plus all legal costs and expenses incurred in closing said account, to the extent not prohibited by law. Those expenses include i.e. reasonable attorney's fees.

**Insurance:** Austin's Violin Shop offers accident insurance to those who wish to purchase coverage. Insurance payments are due with the rental payment on a quarterly basis. See Rental Insurance Contract for details.

**Repairs:** If damage should occur to the rental instrument(s), only Austin's Violin Shop is authorized to provide the necessary repairs. If repairs are made by anyone other than Austin's Violin Shop, the renter may be liable for any damage and resultant repair costs.

**RENTAL INSURANCE CONTRACT**

Austin's Violin Shop provides basic coverage on all our rental instruments. This coverage provides for the cost of normal wear and tear, regular maintenance, broken or older string replacement and bow repair.

**Accident Insurance Coverage** is optional for each rental instrument. Purchase of this insurance provides coverage for all accidents, and loss through theft or fire. This insurance does not cover gross negligence or malicious damage done to the instrument, bow or case. This insurance also does not cover damage caused by pets. The renter is responsible for the repair or replacement cost if such damage occurs.

Austin's Violin Shop recommends Accident Insurance Coverage for renters who fit the following criteria:

- Player is a young child or is around young children
- Player takes rental instrument to school
- Player travels with the rental instrument

**\*Standard Quarterly Insurance Rates:**

Violin & Viola	.....	\$10.00 per quarter
Cello	.....	\$15.00 per quarter
Bass	.....	\$20.00 per quarter

The insurance premium is due along with the quarterly rental fee. Insurance coverage will be provided for those renters who have signed up for coverage and are current with premium payments.
